DIVISION 4. PARADES AND OUTDOOR PUBLIC ASSEMBLIES**Sec. 114-301. Definition.**

(a) As used in this division:

Parade means any **parade**, march, ceremony, show, demonstration, exhibition, pageant, or procession of any kind, or any similar display, in or upon any street, park or other public place in the city.

Sec. 114-302. Permit required; exceptions.

(a) No person shall engage in, participate in, aid, form or start any **parade**, unless a **parade** permit has been obtained from the chief of police.

(b) This section shall not apply to:

_____ (1) Funeral processions;

_____ (2) Students going to and from school classes or participating in educational activities, providing such conduct is under the immediate direction and supervision of the proper school authorities;

_____ (3) A governmental agency acting within the scope of its functions.

Sec. 114-303. Time restrictions.

No **parade** shall be held between the hours of 10:00 p.m. to 8:00 a.m.

Sec. 114-304. Permit application; filing; contents.

(a) Application for a **parade** permit shall be filed with the police chief on forms provided by him.

(b) An application for a **parade** permit shall be filed with the chief of police not less than 14 days before the date on which it is proposed to conduct the **parade** unless waived by the chief of police.

(c) The application for a **parade** permit shall set forth the following information:

_____ (1) The name, address and telephone number of the person seeking to conduct such **parade**;

_____ (2) If the **parade** is proposed to be conducted for, on behalf of, or by an organization, the name, address and telephone number of the headquarters of the organization, and of the authorized and responsible heads of such organization;

_____ (3) The name, address and telephone number of the person who will be the **parade** chairman and who will be

responsible for its conduct;

- _____ (4) The date when the **parade** is to be conducted;
- _____ (5) The route to be traveled, the starting point and the termination point;
- _____ (6) The approximate number of persons who, and animals and vehicles which, will constitute each **parade**; the type of animals, and description of the vehicles;
- _____ (7) The hours when such **parade** will start and terminate;
- _____ (8) A statement as to whether the **parade** will occupy all or only a portion of the width of the streets proposed to be traversed;
- _____ (9) The location by streets of any assembly areas for such **parade**;
- _____ (10) The time at which units of the **parade** will begin to assemble at any such assembly area or areas;
