The following words, when used in this ordinance, shall have the following meanings unless otherwise clearly apparent from the context:

c)	The word "rollerskate" shall include any shoe like device with wheels attached.

	No person shall ride or in any manner use a <b>skateboard</b> , rollerskate, or rotlerskates, upon the following c ways:
	Main Street between Chart Street and North Main Street Bridge;
	2. East Bridge Street (M-89) between Anderson Street and Main Street;

The sidewalks running along the public ways set forth in (1) through (5) above; The sidewalks within any public park unless designated for such use.

Any city owned/leased or maintained parking lot;

Allegan Street (M-89) between Millrace Bridge and Main Street; West Bridge Street between Millrace Bridge and Main Street;

	b)	No person shall ride on or in any manner use a <b>skateboard</b> , rollerskate or rollerskates, with a sail.
		No person shall ride on or in any manner use a <i>skateboard</i> , rollerskate or rollerskates, which is being ed by any vehicle or animal.
		No person shall throw, cause to be thrown, or participate in any manner in the throwing of a frisbee on a fic highway, street, alley, sidewalk or footpath.
		No person shall throw, cause to be thrown, or participate in any manner in the throwing of a frisbee in such anner as to interfere with the lawful use of public highway, street, alley, sidewalk or footpath.
		This ordinance shall not be construed to prohibit the use of frisbees in other areas, provided that such uses not interfere with the lawful use of a public highway, street, alley, sidewalk, or footpath.
